Setting Up Overrides

This section describes the change to the Authorize Student Exceptions page.

When a user attempts to set up an exception to his own ID using the Authorize Student Exceptions component, he receives an error message warning him that he is not permitted to do so. Specifically, when the operator's ID (emplid) is the same as the ID (emplid) selected, the operator receives an error message indicating that he is not authorized to create a student exception for himself.

Processing Local Limits and Splitting Credits

This section describes changes made to local limits and credit splitting functionality.

The COBOL programs, SRPCAGRP.cbl and SRPCARQM.cbl, were modified so that courses that can be used for a requirement line but were unused on the first pass will be correctly used in the second pass when the audit picks up extra units for requirements and requirement groups.

Changes were also made to the COBOL programs, SRPCARQM.cbl and SRPCAGRP.cbl, so that the audit engine correctly identifies courses that have been split and used to the maximum amount allowed while still showing the course as being used.

Using Course Share Sets

This section describes changes made to course share set functionality.

A new field was added to a COBOL program (SRCCASHS.cbl) to track the current share set position being checked. Change was also made to a COBOL program (SRPCAPRG.cbl) to correctly load the value when the process share set restrictions are processed. Also, the program, SRPCARQL.cbl, was modified to correctly select the share set restrictions.
